She encouraged Cllrs to work together, to respect each other and draw on the skills and experience that each can offer. She noted WHPC is also a relatively new council and systems and policies are still evolving and requested Cllrs to show tolerance.</p> <p>Cllr MP referred to a comment by Cllr ABC 26th April (Minute 21/155) with regard his statement that he had felt bullied during some meetings, he does not propose to take this matter further (by involving the Monitoring Officer) but would like informal discussion and measures to improve future conduct of all councillors. His comments were not aimed at any single councillor. It is important to emphasise that all councillors should listen carefully and respectfully to other councillors’ views. Any actions or words which make another person feel intimidated or bullied are unacceptable.
