

# **NOTICE OF CONSULTATION**

## **Woodbury Parish Neighbourhood Plan Submission**

Woodbury Parish Council have prepared and submitted a Neighbourhood Plan for the parish of Woodbury, under the Neighbourhood Planning (General) Regulations 2012 (as amended) and the Localism Act 2011. The plan has been prepared with local community involvement and sets out a vision for the future and planning policies which will be used to determine planning applications in the Plan area.

East Devon District Council are now inviting comments on the Plan under (Regulation 16) Submission Consultation. All comments received will be passed with the submitted documents for consideration by an independent examiner who will recommend whether the draft Plan should proceed to referendum.

The consultation runs from Wednesday 15<sup>th</sup> October to **9am 27th November 2025.**
